## **Annexure - I**

### **Terms & Conditions of EOI for Light Fixture items**

- 1. The rates quoted should be inclusive of all Taxes, Duties, Transport, Loading/Unloading, Packing & forwarding, Octroi, Insurance, WCT, Service Tax, Vat etc.
- 2. No surcharge or any extra cost of any kind shall be paid by SMVDIME.
- 3. **Place of Delivery**: Project site, SMVDIME, Kakryal, Katra- 182301 (J&K).
- 4. The SMVDIME reserves the right to increase or decrease the quantities of items and also place the order as per requirement of the site.
- 5. The successful tenderer shall have to furnish E.M.D equal to 2% of the cost of approximate quantity of items of the negotiated prices in shape of CDR / FDR pledged to the Director, SMVDIME, Kakryal.
- 6. The successful tenderer shall have to furnish security deposit equal to 5% of the cost of approximate quantity of items of the negotiated prices in the shape of CDR / FDR/ Bank Guarantee in favour of SMVDIME which shall be returned after the defect liability period.
- 7. The approved / successful company/ authorized distributor shall have to sign an agreement on a non-judicial stamp paper with the Director SMVDIME within ten days from the date of issuance of the notice of approval.
- 8. The EOI shall remain valid for 90 days for acceptance from last date of submission of same.
- 9. The rates once quoted/ negotiated with the company shall be final and shall remain valid for a period of six months for the date of execution of the agreement.
- 10. The manufacturer shall have to guarantee the availability of spares / consumables required if any in the market for at least 10 years.
- 11. The tenderer viz. manufacturer / company's authorised distributor shall have to furnish the undertaking about the following:
  - a. that the manufacturer / authorised distributor is not blacklisted by any Govt. / PSU / Autonomous Body;
  - b. that the rates quoted are lowest and the manufacturer / authorised distributor will not supply such material at the rates less than approved by SMVDIME to any other agency/ organization during the period of agreement with SMVDIME.
- 12. At the time of installation the company shall provide services of technical experts who will supervise and technically guide the concerned contractor.
- 13. The company shall quote the guarantee / warranty in respect of all the items alongwith price bid.
- 14. The delivery period shall be 3 weeks from the date of issue of supply order.
- 15. The mode of payment shall be 80% on delivery pf the material at the project site and verification of the items as per specifications shown in the supply order and balance 20% after successful installation of all the items.

- 16. The minimum defect liability period will be one year from the date of successful installation of the material which shall include the free replacement and installation of the defected parts and in case the warrantee / guarantee period offered by company is more, the same shall be applicable.
- 17. The supply should be guaranteed against any manufacturing defects, faulty design materials or workmanship. The delivery of defective/ faulty material/ equipment/ stores shall not be taken and if it is found so after delivering the same shall be replaced free of cost at the ultimate destination of SMVDIME without any extra cost.
- 18. The successful tenderer shall have to submit the samples of materials to be supplied, for approval of SMVDIME.
- 19. **Right of Rejection**: SMVDIME reserves the right to reject the defective / substandard material(s) items if any supplied by the supplier. All the items/ material should be as per approved samples.
- 20. **Penalty for Delay:** If the delivery of stores/ items ordered is delayed, SMVDIME reserves the right to impose penalty of 0.5% of the Purchase Order amount per week subject to a maximum of 10% of the value of the order and deduct the same from the bill of cost.

## 21. **Dispatch instruction / supplies :**

- a) Stores/ items ordered shall be delivered at the Project Site, SMVDIME Kakryal, Katra-182301 (J&K)
- b) The goods should be securely packed at suppliers expenses to avoid any damage in transit.
- c) The material shall be inspected at the Project site of SMVDIME by the authorized officer/s before acceptance. After acceptance of supplies bill shall be submitted in triplicate along with stamped pre-receipt and certificate regarding receipt of accepted supplies to the Divisional Manager (Engineering), SMVDIME.
- d) The equipments/ stores / fixtures along with all the accessories shall be supplied in one consignment/ dispatch only.
- e) Part supply shall not be accepted.
- 22. DELIVERY CONDITIONS SHALL BE STRICTLY ADHERED OTHEREWISE PENALTY, as per relevant clause will be imposed.
- 23. The erection/ commissioning demonstration for satisfactory working of the supplied items shall be provided by the supplier at SMVDIME without any extra charges.
- 24. SMVDIME's responsibility shall cease after intimation by ordinary post to the supplier about the items / stores received in damaged / non-working / malfunctioning conditions or sub-standard supplies.
- 25. In case of any dispute arising out of (i) the interpretation of any of the clause/ clauses mentioned herein (ii) the rejection of the equipments / stores by SMVDIME (iii) the cancellation of the order, the decision of the Director, SMVDIME shall be final, conclusive and binding on the supplier. All legal disputes shall be subject to the Jurisdiction of the court in Distt. Reasi, J&K, India.

- 26. The Director, SMVDIME reserves the right to reject any tender without assigning any reason, thereof.
- 27. The interested manufacturers/ representative of companies can visit the SMVDIME construction site in their own interest.
