INSTRUCTIONS AND CONDITIONS FOR TENDERERS

- 1. Before tendering, the Tenderers, in their own interest, are advised to visit site to acquaint about the condition of site, its surroundings, terrain, climate, availability of labour, power, water, communication facilities etc. The Owner/SMVDIME shall bear no responsibility for lack of knowledge on their part about the site and other conditions or any information relating thereto. The consequences of the lack of knowledge, as aforesaid, on the part of the Tenderer/s shall be at the risk and cost of concerned tenderer.
- 2. Before tendering, the Tenderers shall carefully examine the tender documents, conditions of contract, Drawings and other matters referred to therein, the schedules and Bill of quantities and if there be or appears to be any ambiguity or discrepancy in any of these documents or between figured and measured dimensions and other aspects of the Drawings, the tenderer shall immediately refer the matter to the Owner/SMVDIME for clarification before last date of submission of the tender/s.
- 3. The Tenderer shall complete the annexed Tender Form, Schedule/Bill of quantities by quoting the rate against each item under rates column shown in the bill of quantities, supported with all information and documents called with the tender. The Tenderer shall sign each page of the Bill of Quantities, schedules, conditions of contract etc appended with tender documents & shall be duly stamped with contractors/Company's seal.
- 4. The quantities indicated in Bill of Quantities against various items are approximate and are merely for general information without undertaking as to the correctness thereof and without any obligation relative thereto upon the owner.
- 5. The Tender form and the documents attached to it shall not be detached or rearranged and no alteration, mutilation or insertion other than filling in of the required blank spaces shall be made in any of the documents attached with the tender documents.
- 6. All documents of the tender are to be read in conjunction with each other and the Tenderer will take this into consideration while quoting the rates.
- 7. The quoted rates shall be entered in ink both in figures and words and in the event of any discrepancy between the two, rates entered in words shall only be considered. Cuttings, over writings must be avoided and if necessitated should be initialed. SMVDIME shall have the right of arithmetical checking and correction of figures. In case of a tender where the prices of any items appear unrealistic, such a tender will be considered as unbalanced. The tender issuing authority reserves the right to call for the rate analysis in such items which are in his opinion, unbalanced and in case the tenderer is unable to provide satisfactory explanations, the SMVDIME reserves the right to disqualify such tender/s.
- 8. The validity of tender shall be 120 days from the date of submission of tender; and validity of contract will be 8 months from the date of commencement of the work unless otherwise notified.
- 9. The SMVDIME (owner) reserves the right to reject, accept or prefer any tender in part or /in full without assigning reasons thereof.
- 10. The conditional tender/s will not be accepted
- 11. The SMVDIME (owner) reserves the right to negotiate the quoted rates, terms and conditions with the lowest tender or any of the other tenderers to ascertain the suitability of the acceptable offer and no claim or objection on this account will be entertained.

12. The Tenderers must possess valid Permanent registration for fabrication of Rolling shutters.

13. Earnest Money Deposit:-

- i. The earnest money deposit for the amount specified in tender documents in the shape of CDR or FDR valid for at least 12 months from the date of submission of tenders drawn on any scheduled/ nationalized bank pledged in favour of Chief Accounts Officer, SMVDIME, payable at Kakryal/Katra, must accompany the tender failing which the tender will be summarily rejected. The EMD of successful tenderer will be retained by SMVDIME and released after completion of work.
- ii. The earnest money deposit of unsuccessful Tenderer/s will be released after acceptance of the successful tender / issuance of Notice/Letter of Award in favour of successful Tenderer.
- 14. In case last date for submission of tenders is declared as holiday the next working day shall be considered as last date of submission of tenders. The tenders received after the scheduled date and time will not be entertained/considered.
- 15. The successful tenderer shall keep liaison with the Owner till finalization of Letter of Award within validity period. No excuse whatsoever will be entertained for not having received the allotment letter /letter of award through post or otherwise.
- 16. After the Letter of award is communicated to the successful Tenderer, the contract shall be deemed to be complete and binding upon such Tenderer/contractor. The formal written deed of agreement incorporating all the terms and conditions of the contract including those mentioned in NIT, Tender documents and letter of award shall be drawn by the successful contractor with SMVDIME within 20 days after the issuance of Letter of Award.
- 17. The Tender shall be submitted in two bid system i.e. in two envelops as under:-

- 18 The Technical Bid contained in Envelop No. 1 will be opened on the same day or any other date convenient to the SMVDIME in presence of the Tenderers or their authorized representatives who may choose to be present.
- The Financial Bid of only those Tenderers, who qualify as per the eligibility criteria on the basis of documents submitted in the Technical Bid shall be opened on a date which shall be communicated separately to the qualified Tenderers. The Financial Bid of the Tenderers who could not qualify will neither be opened nor considered.
- The Owner/ SMVDIME will not pay for any expenses which may be incurred by the Tenderer/s in connection with site visits, inspection of the site etc and efforts put in for the preparation of tender for submission.

- 1. **The Site:** The site of the works is at SMVDIME Complex, Kakryal (Katra), J&K.
- 2. **Description of Work**: -"Providing, Fabricating & Fixing of Rolling shutters in SMVDIME."
- 3. **Time of completion**: will be One Month from date of issue of Notice of Award/ LOI. Validity of Contract will be for 8 months from the date of Commencement of work.
- 4. **Form of Contract**: Item Rate.
- 6. **Bid documents**: Prescribed Tender Form and Bill of Quantities in specified manner.
- 7. **Submission of Bids**: The intending Tenderers shall submit Sealed Tenders in original and completed in all respects in two bid system i.e. "Technical Bid" and "Financial Bid" which should reach in the office of Shri Mata Vaishno Devi Institute of Medical Excellence having its office at Administrative Block, Shri Mata Vaishno Devi University, Kakryal (Katra), J&K by or before scheduled date of submission of tenders in the following manner: -
 - (A) Envelope No.1 : marked as "TECHNICAL BID (Envelope -1)" and should contain the following: -
 - i) Letter from contractor, accepting all terms, conditions and technical specifications of tender.
 - ii) "Earnest Money Deposit" of ₹ 2,000/- in the prescribed manner.
 - iii) Demand draft of ₹ 500/- in case tender document is downloaded from website.
 - iv) Certified copies of Registration Certificate (issued by the Registrar of Companies in case of Company and issued by Registrar of Firms indicating names etc., of all registered partners, incase of Partnership Firm), Partnership Deed and Power of Attorney or Memorandum and Articles of Company in case of Limited / Private Limited Companies will have to be furnished along with the tender to render the tender eligible for consideration alongwith Registration from DIC.
 - v) Volume -I duly signed and accepted.
 - vi) Power of attorney if any.

The above mentioned two envelopes shall be put in one envelope which should be duly sealed and superscribed as "Providing, Fabricating & Fixing of Rolling shutters in SMVDIME"

Last date of submission of Tender: - 11th March 2011 (upto 2 p.m.). In case last date is declared as holiday, the next working day shall be considered as last date for submission / receiving of tenders.

8. Acceptance/ Rejection of tenders:-Tenders which are not properly filled or are mutilated or have pages missing or generally not complying with the tender conditions will be rejected.

The Tenderers should quote their rates both in figures & in words (English) and in case of cuttings etc., rates entered in words shall only be considered. SMVDIME shall have the right of arithmetical checking and correction of the figures.

In case of a tender where the prices of any items appear unrealistic, such a tender will be considered as unbalanced. The tender issuing authority reserves the right to call for the rate analysis in such items which are

in his opinion, unbalanced and the tenderers is unable to provide satisfactory explanations, the SVMDIME reserves the right to disqualify such a tender.

In case of the tender submitted by an individual, it shall be signed by him and his full name and complete address shall be given. If it is submitted by a partnership firm it shall be signed in the name of the firm by a partner of the firm who shall sign his own name and give the name and address of each partner of the firm and attach a copy of `Power of Attorney' with the tender authorizing him to sign on behalf of the other partners

No alterations, amendments or modifications shall be made by the tenderer in the Notice Inviting Tenders, Instructions to the Tenderers, Tender Form, and Conditions of the Contract, Drawings and Specification and if any such alterations are made or any special conditions attached, the tender is liable to be rejected without reference to the tenderer.

Canvassing in connection with tender is strictly prohibited and tender submitted by tenderers who resort to canvassing will be liable to rejection.

The SMVDIME / Owner does not bind itself to accept the lowest tender and reserves the right to reject any or all tenders without assigning any reason(s) whatsoever. Non-acceptance of any tender shall not make the Owner or SMVDIME / Owner's Representative liable for any compensation or damages.

It shall be the prerogative of the SMVDIME / Developer, after reviewing the potential, capability and financial offer from the Contractor, to decide on awarding the whole contract to one Contractor or separately award to multiple Contractors.

At any time prior to the Tender submission date, the Owner may, for any reason, whether on its own initiative or in response to a clarification requested by a tenderer, amend the Tender documents by an Addendum (The "Addendum"), which will be notified in writing to all Tenderers. The Tenderers shall promptly acknowledge receipt thereof.

The amended clauses and not the relevant unamended clause of the Tender Document shall form part of the Tender Document, and the tender document shall be construed and interpreted accordingly.

The notice inviting tenders will form part of the tender document and the Contract Agreement to be executed by the successful tenderer.

9 Earnest Money Deposit: (E.M.D): -

Earnest Money Deposit of specified amount in the form of CDR/FDR valid for at least 360 days (twelve months) from the date of submission of tender and pledged in favour of The Chief Accounts Officer, Shri Mata Vaishno Devi Institute of Medical Excellence shall be submitted along with the Tender in the envelope marked as "Technical Bid".

The E.M.Ds of the unsuccessful tenderer will be returned after acceptance of the successful tender.

The E.M.D of the successful tenderer shall be forfeited if he fails to sign the prescribed agreement and / or fails to start the work within FIFTEEN DAYS of order to commence the work.

The E.M.D. of the successful contractor will be retained by Shri Mata Vaishno Devi Institute of Medical Excellence till completion of work and finalization of the contract.

- **PERIOD OF VALIDITY:** The tender shall remain valid for acceptance for a period of ONE HUNDRED TWENTY DAYS from the last date for submission of the tenders. If any tenderer withdraws his tender before the said period or makes any modification in the terms and conditions of his tender, then the Owner shall be entitled to forfeit the Earnest Money Deposit of such tenderers.
- INSPECTION OF SITE: Every tenderer is expected to inspect the site of the proposed work and acquaint him with the site conditions, working space available for material / fabrication yards, stores, offices and any other contractor's facility, approaches, etc. before quoting his rates. He must go through all the drawings, specifications and other tender documents. Submission of the tender shall be deemed to be due compliance with this clause.
